## MEET . . .

*(Occasionally I will be able to corner a member who is a regular attendee and get them to write something about themselves. If that person is an officer of the club, this may take the form of writing about their job. The entry this time is from **Bill Ellern**, a member of our Board of Directors. If any regular attendee wants to write about some personal information, please get me a short piece of material. Remember, I may be ruthless in my editing, so do not write about Ruth.)*

### Growing the LASFS - 4 by **William B. Ellern**

Last month I wrote about a vision. If you read it and liked it, you have a bunch of questions. The answer to all of those questions is "Put together a dedicated organization with a purpose." As pointed out by "The Purpose Driven Church" by Rick Warren, a clear purpose statement forms the foundation of an organization. With a little purpose, you get a little organization that can only do a little bit. With a big purpose, you can build a big organization that can do anything.

My church has a purpose statement. It's gobbledygook. It was written by people who didn't know what they were doing, or people who didn't want to lose their control of their little group and fear a big one. A clear statement of the purpose is essential. A clear statement of the purpose of LASFS should be written down and made known to each member of the club. It immediately does five things to those who read it and understand it.

1. **It builds moral.** If everyone has the same purpose, it unifies them. It gives them a mission. People with a purpose don't waste time in arguments over trivialities. It solidifies agreement. People in the group can say to others "Our group does this!" Without a purpose, morale is low and people go somewhere else. Nothing discourages the people in a group like not knowing why it exists.

2. **It reduces frustration.** It permits the group to ignore things that don't matter. It defines what we need to do, AND what we don't need to do. It helps those around you move in the same direction. It increases effectiveness. You can measure your job

against the goals. It replaces personal agendas; because you can measure the job someone else wants you to do against the real goals.

3. **It allows concentration.** It focuses the power of a group. A flashlight illuminates; a laser cuts through steel. How many committees and activities does LASFS have? How beneficial are they? How much more beneficial would they be if they were focused with the purposes of LASFS. "But my favorite activity won't be on your list!" you say. Wrong. Activities fall out of purposes. The purpose of your activity may change, but I feel certain that what we are presently doing will remain.

4. **It attracts cooperation.** When people know where an organization is going, they want to join it. It gives meaning, purpose, and direction to life. It excites people and they will support it. It gives them a mission. Our purpose should be explained to every person who wants to join — before they join. If you allow people to become members without understanding your purposes, you are asking for trouble later. New members often have personal agendas, and preconceived ideas about the club. Unless you deal with them up front these will cause problems and conflicts.

5. **It assists evaluation.** If properly written, the purpose statement becomes a way to measure the club's health and growth. It helps answer two questions. "What is our business?" and "How is our business?" What do we need to do better? Are we on course?

Now before you say, "YES! That's it! A purpose statement and we're on our way!" I want to warn you that it is only a very important **first step** along a path filled with potential problems. It is the step upon which others will be based, and it must be done correctly.

**Special Order of Business:** Dwain Kaiser has been hospitalized on account of his heart. He was having a bout of congestive heart failure.


The **Menace** were read and loudly corrected, and then approved as "Submitted in writing before the meeting, but not enough signatures."


**TREASURER'S REPORT:** Liz's report showed Treasury, \$15,824.17; Festival of Books, \$122.54; Library Fund, \$1,004.22; Video Fund, \$152.89; Century Fund, \$28,118.46; Key deposits, \$350.00; Video R&R, \$144. Total club funds: \$45,716.00.

Liz distributed the year-to-date and proposed year-end Budget. After discussion, it was approved by voice vote.

**ARCHIVES:** Bob Null had added stuff. Mike Stern said he wanted to round up people willing to discuss a recommendation to start a Westercon archive.

**MORE CLUB MACHINES:** There was more discussion of the Gestetner optics. Mike Stern asked for a sense of the Board how many thought it would be a good idea to make the repair. Most directors did. Stern asked Bob Null to schedule a service call. The directors also discussed how often to have regular service done. The estimated cost for a routine maintenance call seems to be \$300 according to SCIFI's experience.

Mike Stern asked Liz to add \$300 to the budget for Gestetner service.

Shaun Lyon announced that he is donating a fine computer. Bob Null talked about the limitations of running some of our old software on newer computers. Glycer asked whether any LASFS computer was loaded with newer DTP software than Ventura Publisher. None was, but Shaun said he would donate his copy of PageMaker.

**HALL RECONSTRUCTION:** Under the subject of plumbing, Bob Null described the pipe repairs that could be done for \$1600. He wanted to avoid repair methods that required cutting up the sidewalk, due to the expense of restoring it to city specifications afterwards. He is getting estimates.

Bob also said the termite people visited. There were no termites, but they found a puddle of water under the building. Also, some wood left over from the library reconstruction. He will ask Scratch to go under the building and take it out, so it can't be a source of future infestations.

The directors talked about access for a wheelchair-bound member. Mike Stern had talked to him, and the member's opinion is there needs to be a ramp built one foot in length for each inch of elevation (if you don't have a railing; if you do, it's one foot for each 2 inches of elevation.) Stern supposed a 6' ramp with a railing would do the job.

Joe Zeff wondered about our hypothetical parking spaces in between the buildings that might be blocked. Mike Thorsen asked about the requirement to do all ADA improvements if we do any. Kim's opinion was that if we're not required to do it, this is a moot discussion. Stern felt we are morally obligated to do it. Ed Green said that since the person is a member, we may not have a choice. Null said that we might even have to make the library and entire premises wheelchair-accessible. Bruce suggested dropping the matter until we absolutely have to make improvements. Stern felt if we weren't proactive, we'd wind up further in the hole.

Mike Thorsen reported on the large outdoor umbrellas that had been purchased. Also the new tables.

**LIBRARY:** Michael Mason said donations are down from five boxes to one box a week, so they are catching up cataloguing

**VIDEO:** Mike Stern reported on a video/library work party. They worked right through TRIPE.

**LISTS:** Children's Recommended Reading List: No Greg Barrett, no report.

APA-L: Bruce said other projects have taken priority.

E-Mail List: Joe Zeff sent out an update. He will soon distribute a typo correction. Stern asked him to add the officers and directors to the list.

**LASFS.ORG:** Stern said something was done on the page this week after lots of prodding. Bruce congratulated him on the rapid update of procedural officers.

The directors discussed whether Loscon.org is up or not. Stern sent Chaz a tickler, and Chaz had yet to respond.

**LOSCON 27:** Shaun reported a PR is being sent out this week. They threw two well-attended parties at BayCon. Shaun thanked various fans who pitched in at the tables and parties. There will be a party at Agamemcon.

**LOSCONS OF THE FUTURE:** Christian McGuire is trying to get the local representative's supervisor involved in their meeting. There is a great deal of difference between the new proposed hotel contract and our previous ones.

**HULALACON:** Tadao said there had been 90 people, and the event will turn over approximately \$2000. He has re-enlisted as chair of next year's LaLaCon - it will be called FaLaLaCon. Liz mentioned the big auction income came from items anonymously donated by Marjii Ellers' estate.

**RECYCLING:** Bob said recycling brought in \$49.85.

**CONVENTION DELEGATES:** New delegates to Westercon were Kim Marks Brown and Liz Mortensen.

**LETTER TO CRASHERS:** Stern had e-mailed the letter, with a BCC to the directors.

**PRECINCTS OF FELICITY:** Ed Green said the new Community Service officer was distinctly lukewarm about their discussion. The police are preoccupied with the Democratic National Convention. The officer told Ed we should use our common sense.

**LETTER FROM A NEW MEMBER:** Liz read a letter from Ron Gordon, which she had copied for the directors. Gordon made some suggestions, including having a "solid presentation" on the program once a month. There was lengthy discussion about including this wonderful letter in *De Profundis*. It was decided that by deeming it



Other than that, it sort of reminded me of The Love Camp in the Ozarks, but with a Southern California flair.




