

Two ladies from Project Linus were present to receive the accumulated donations. So far, we have completed twenty, with more to come. Blankets are being sent to a number of hospitals, as well as the LAPD. The nationwide organization is in trouble, and may dissolve. The local chapter will continue, as handmadehugs.org, thus following in LASFS's own tradition.

TREASURER'S REPORT: \$45,820.40 TOTAL, INCLUDING SEVERAL SPECIAL FUNDS. The Treasurer thanked Ed Green, Tadao Tomomatsu and Dale Hales, LASFS auctioneers. We have also had

several special auctions for the ladies. We have had several auctions in recent weeks totaling over \$100 each.

APPLICATIONS FOR MEMBERSHIP: Walter Lee, Michele Wolfe, and Thomas Wolfe. All were accepted, unanimously.

CRASHERS: Mike Stern has discovered that we can't expel the crashers as easily as we had thought. The Bylaws state that they must be notified that the Board is discussing expelling them, and allow them to be present to defend themselves at that time. the only way we can expel without notice is for missing dues, but LOSCON memberships aren't dues. After much discussion, it was decided to drop the expulsion proceedings, as the crashers aren't attending any LOSCON functions or meetings anyway. As some members of the Board weren't certain what the requirements are, we checked, finding that a written petition is required and the members must be notified by Certified Mail of a board meeting at which the motion will be discussed and voted on. A written petition was submitted, signed by eight LASFS members. The crashers will be notified that the motion will be discussed at the November Board meeting.

PETITION FOR TERMINATION OF MEMBERSHIP

We the undersigned members of the LASFS, Inc., request the Board of Directors consider the termination of the membership for the following LASFS members: Lee Downing, Eric Kelstrom, Drew Rhine. These three members attended programming events at LOSCON 26 without paying for membership. They were informed numerous times by convention officials to pay, but never did. We feel this behavior is in the worst interests of the LASFS, and such activity must be discouraged in every possible way.

CLUB MACHINES: Joe Zeff bought some network hubs, one for the front building. Bob Null pointed out that the PA gets reset, constantly, making it hard to adjust. Labels will be printed for the PA.

HALL RECONSTRUCTION: The canvas shades have taken wind damage, and will be sewn up and a chair needs welding. The socket for one of the outside lights has broken, and will be replaced. Scratch is now about 3/4 done with cleaning out under the front building, so we should be able to get the plumbing done Real Soon Now. The treasurer was asked to include money for paving in the next budget. Liz has found a source of a paving material, consisting of small stones epoxied together to make a smooth surface. Liz and Kim were appointed a Patio Committee.

LOSCON.ORG, LOSCON 27, LOSCON 28: No report.

LOSCONS OF THE FUTURE: We still have a contract, and it's one we can live with.

ARCHIVES: There have been two archive sessions. Eylat attended the first, but was unable to return for the second. Many of the filing cabinet drawers now have labels, and templates are available. We haven't gotten in touch with Mike Donahue. We'll give the tapes to him when we see him. Marty Cantor reminded all secretaries to deliver corrected copies of the minutes to the archives. Bob told us that there is a specific drawer for contributions, labeled "Incoming."

ESTROGEN ZONE: It was well attended, with more gentleman than ladies in attendance, with at least 25 people. Much fun was had by all, and it will continue.

LALA7CON: It is still proceeding apace. They're still working on the guest list and will announce it RSN.

NIPPON 2007 Mike Stern signed a bunch of paperwork for it, so the account's ready. We should like the paperwork from lasfs.org when Chaz gets to it.
