*'For any vote required by these bylaws, any member who is otherwise eligible to vote may do so in person if they have attended four or more of the last 13 regular Society meetings; for any vote not so required, this additional restriction does not apply.'*

In the absence of the Secretary, the Chairman may appoint a Secretary pro tem.*

Remove the word "and" just before "(4)."

Change (3): substitute "full copy" for "précis."

Add "(4) shall keep, at the principal office of the Society, a copy of the minutes of the meetings of the Board of Directors, which shall be accessible to any member on demand, and"

Change: number (4) to number (5)

To Article IV, Procedural Officers, Section 7, Scribe, make the changes listed below the relevant copy of the appropriate section of the by-laws shown in italics.

*The Scribe: (1) shall keep, at the principal office of the Society, a book of minutes of the meetings*

*of the Society, which shall be accessible to any member on demand; (2) shall provide a précis of the minutes of each Society meeting for publication in the Society newsletter; (3) shall handle the correspondence of the Society, and (4) shall notify all Standard Members of the date and purpose of all elections, proposed amendments to the Articles of Incorporation or to these by-laws, and special events.*

At the end of (1): "and shall maintain the minutes section of the archives."

Change (2): "shall provide a copy of the minutes of each Society meeting for publication in the Society newsletter (whose editor may edit and condense them as necessary as long as said editing shall not distort the meaning of said minutes.)"

Signed by enough people to merit consideration by the Society. This item will be the main attraction September 21, 2000.

A motion to adjourn was defeated in some arcane fashion, leaving us no choice but to move right along.

Registrar: Beckie and Lynx answered the question, "Who's new, pussycat?" The answer: Richard Puciteri (sp?).

Before this Mother's Day meeting, Kim declared, "I'm the only legitimate mother here." Chair Mike Stern called the meeting to order.

**MINUTES:** Glycer read Zeff's April minutes. Zeff read Glycer's March minutes. Shaun corrected Marv Wolfman is Hulalacon GoH, not artist GoH. Stern said that the March minutes were approved as corrected, and the April minutes were approved as read.

**NEW MEMBERS:** Applications were received from Stuart Kalbrosky, Randy Alkire, Jacob Lee, William Wilkerson. They were approved as members by voice vote, unopposed.

The report showed Treasurer, \$14,234.30; Festival of Books, \$155.28; Library Fund \$1,030.25; Video Fund, \$165.39; Century Fund \$27,036.27; Key deposits \$340.00, Video R&R \$144. Total club funds: \$43,105.00.

The club has a new Patron Saint, Gail Selinger. Gail achieved instant sainthood by writing a check for \$1000.00.

**ARCHIVES:** Bob Null said "The usual."

**CLUB MACHINES:** There was little new to report about the Gestetner or the computers. Bob explained that he'd stocked the paper bank and changed the locks.

Marty Cantor demonstrated a chronic problem with the print quality of the Gestetner. His test convinced him the problem was in the optics.

There was a discussion of handling video at Hulalacon since it did not appear the new video projector would be on hand.

**HALL RECONSTRUCTION:** Bob Null said the APA-L room holes had been filled. He reported that the rain gutter came off the front of the building. It requires a minor repair.

Kim suggested that somebody build a UPS drop-off box - since it's weather, not security, that has been our problem. There was a discussion, and various members volunteered to have such deliveries made to their place, in lieu of a box.

Liz Mortensen raised the question of access to a bathroom for a member in a wheelchair. Kim suggested moving Monstro and building an outside door into the Freehafer Hall bathroom. Marty Cantor suggested a ramp. Joe Zeff reminded all that if we make any handicap-access improvements, we will lose the building "grandfathered" status and have to make all the ADA required upgrades. Bob Null suggested checking our options with Charlie Jackson II who has thoroughly researched the access issue.

Mike Thorsen said he, Bill Ellern and Liz Mortensen were going to Costco and buy at least one expandable umbrella.

Bob Null had discovered tables available at a good price. Joe Zeff, seconded by Kim Marks Brown, moved to purchase four six-foot tables. The motion passed by voice, unopposed, with Mike Stern abstaining.

**LIBRARY:** No report.

**VIDEO:** Bob Null said the collection received more donations from Ed Green.

**LISTS:** Children's Recommended Reading List: Mike Stern said Greg Barrett got his new list out by the Festival of Books, where it was one of the most-wanted items.

**APA-L:** Karl Lembke said he knew of no progress.

**E-mail List:** Joe Zeff will shortly be sending out an

update.

**HALL DECORATION:** Ed Green said that would be handled offline.

**LASFS.ORG:** Stern said that the move to the new ISP is still in progress. Functionality seems to have regressed - an e-mail for the Chairman of the Board went to Bruce, indicating an old address list had been installed.

**LOSCON.ORG:** Stern has exchanged e-mails with Chaz. Chaz registered Loscon.org on a service that only uses credit cards and won't accept payment by check, contrary to the specifications of the treasurer. Liz requires that he transfer ownership of the site to LASFS, and transfer the hosting to Network Solutions so the costs can be paid by check. Stern said he will send Chaz a tickler.

Kim asked why LASFS doesn't get a credit card. Liz said she would ask Citibank if we can get one to go with our account.

Mike Thorsen said the club should investigate getting a business account at Costco. However, several members said they already have an account are letting club stuff as needed.

**LOSCON 27:** Shaun reported there had been a well-attended committee meeting on April 29.

**LOSCONS OF THE FUTURE:** There was no report.

**HULALACON:** Guest names and membership numbers were reviewed.

**RECYCLING:** bob said recycling brought in \$39.20.

**CONVENTION DELEGATES:** Michael Mason and Liz Mortensen were named delegates to Westcon.

**FESTIVAL OF BOOKS:** Mike Stern said the LASFS table was in a decent location, next to SFWA and Dangerous Visions.

**LETTER TO CRASHERS:** Stern said it hadn't been mailed. Shaun asked why. Stern said he didn't have the addresses and the letter in the same place.

**PRECINCTS OF FELICITY:** Ed Green spoke to the Community Service officer at the precinct station. But he's transferring tomorrow. So Ed will meet with his follow-on at a more convenient time. The replacement is supposed to be on call by the end of the month. Ed's mission is to explain our Friday night RPG and fantasy card game playing so that the

police won't overreact to any potential complaint.

At this point, Glycer hastened off to cook Mother's Day dinner. Shaun Lyon took over the secretarial chores.

#### **MORE NEW BUSINESS:**

(Shaun Lyon dutifully took over from Mike Glycer at this point in the festivities.) Bob Null said that redoing the plumbing around the front pavement would cost \$1600; the pipes were rusting up front and we already had two patches. Stern asked when we had to repair; Bob said it wasn't an immediate issue. Liz noted that it was best to spend the money and fix. Kim wanted to know if we could get a second estimate from her plumber. Since the building is raised (not on a slab) we could get the plumber to go under the building. Liz wanted the estimate before the next Board meeting because she needs to present the new budget in June.
